Key performance indicators of the priority direction:  
**I. CREATING SUITABLE CONDITIONS FOR EACH PERSON TO REALIZE THEIR POTENTIAL**



Increase the average life expectancy of the population to **78 years;**



Resolving **70 per cent** of appeals of the population in need of medical assistance **at the primary level;**



Ensuring **100%** coverage with **preschool education**, introducing **50** educational programs and the **“double diploma system”** with foreign universities included in the **“Top-500”**.



Reduce poverty **by 2 times by 2026;**

Increase the **gross domestic product** to **160 billion dollars** and **per capita** indicator to **4 thousand dollars**;



Build more than **1 million affordable housing** units ;



Increase the share of **deeply processed industrial products** in the industry by **2.5 times** and increase the percentage of **technological developments** to **32%**;



Increase the share of the **private sector** in the economy to **85 per cent**;



**Doubling labour productivity** in industry;



Increase the volume of **exports** to **45 billion** dollars.

**Task**



A **Republican Commission** will be established to implement the **“Uzbekistan - 2030” Strategy**



will organize the **quality** implementation of the Strategy;

will coordinate **preparation of appropriate annual programs** for their performance and execution.



A **parliamentary commission** will be established **at the Chambers of the Oliy Majlis**



will carry out parliamentary control over the **implementation status** of tasks of the Strategy and the **purposeful and effective use of the funds allocated** within it;

will **hear** and **critically discuss** the **reports of the ministers**.





## MECHANISMS OF ORGANIZING THE IMPLEMENTATION OF THE STRATEGY

**Local Councils**



*will develop a plan of measures* for the implementation of the Strategy in their regions and discuss it **every month**



**Government**



*will critically discuss* the implementation of the Strategy quarterly, **take appropriate measures against the ministers** concerning activities that are not completed on time and in full



**Agency for Strategic Reforms**



*will monitor* the implementation of the Strategy **monthly**, develop **instructions** for its implementation, and make proposals regarding the **responsibility of officials** for the items that are not implemented
